**ORDER LIFTING SUSPENSION**




**MOTION TO LIFT SUSPENSION ORDER**

The Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Victoria Hastings, now moves that the Suspension Order issued December 20, 2019, in this matter be lifted. In support of this request, the Department asserts the following:

1. Sabrina N. Lloyd (“Respondent”) is a licensed nonresident insurance producer holding license number 775944.
2. On November 26, 2019, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a letter requesting a list of appointments.
3. More than ten (10) days elapsed after the Commissioner requested a list of appointments without a response from Respondent.
4. Pursuant to Indiana Code §27-1-15.6-12(g), on December 20, 2019, the Commissioner issued a Suspension Order suspending Respondent’s license until such a time as the Commissioner received Respondent’s list of appointments.
5. On January 6, 2020, the Department received Respondent’s list of appointments.

WHEREFORE, the Department respectfully request that the Commissioner issue an order lifting the suspension of Respondent's license and all other relief just and proper upon the premise.

**FINDINGS OF FACT AND SUSPENSION ORDER**

WHEREAS Sabrina N. Lloyd (“Respondent”) is a nonresident insurance producer holding license number 775944, since September 12, 2011;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner of the Indiana Department of Insurance (“Commissioner”) with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request, within ten (10) days of receiving a request;

WHEREAS, on November 26, 2019, the Commissioner mailed Respondent a letter requesting a list of appointments at the Respondent’s address of record via certified mail article # 7017 2620 0000 5741 3854;

WHEREAS, certified mail article # 7017 2620 0000 5741 3854 sent to Respondent was returned as “Not Deliverable as Addressed” and “Unable to Forward;”

WHEREAS, Indiana Code § 27-1-15.6-12(b)(17) provides that the Commissioner may suspend an insurance producer’s license for failing to timely inform the Commissioner of a change in address in violation of Indiana Code § 27-1-15.6-7(h);

WHEREAS, Respondent has failed to provide a change of address to the Commissioner within thirty (30) days after the change;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days and failure to provide a change of address within thirty (30) days after the change constitutes a violation of Indiana Codes §§ 27-1-15.6-12(g) and 27-1-15.6-12(b)(17);and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

**IT IS THEREFORE ORDERED BY THE COMMISSIONER** that Respondent's license #775944 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
