FINAL ORDER

The Indiana Department of Insurance ("Department"), by counsel, Victoria Hastings, and Jeremy D. Molyneaux ("Applicant"), a nonresident producer applicant, signed an Agreed Entry which purports to resolve all issues involved in the above-captioned cause number, and which has been submitted to the Commissioner of Indiana Department of Insurance ("Commissioner") for approval.

The Commissioner, after reviewing the Agreed Entry, which places Applicant on probation for a period of one (1) year and levies a civil penalty in the amount of two hundred fifty dollars (\$250) due to Applicant's criminal history, including a misdemeanor conviction for two (2) counts of Solicitation to Commit Burglary in the Third Degree, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry, attached, as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

- 1. Applicant's nonresident producer license shall be approved, and Applicant shall be placed on probation for a period of one (1) year, beginning the date of this Final Order. During the probationary period, any violation of Title 27 of the Indiana Code will result in the Department seeking immediate revocation of Applicant's license.
- 2. Applicant shall pay a civil penalty in the amount of two hundred fifty dollars (\$250) to the Department within thirty (30) days after the Commissioner signs this Final Order.

AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Victoria Hastings, and Jeremy D. Molyneaux ("Applicant"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance ("Commissioner").

WHEREAS, Applicant's home state is Arizona, where Applicant is licensed and in good standing;

WHEREAS, on October 3, 2019, Applicant applied for an Indiana nonresident producer license;

WHEREAS, on said application, Applicant disclosed a September 1, 2006, conviction for two (2) counts of Solicitation to Commit Burglary in the Third Degree, a Class 1 Misdemeanor, in the State of Arizona;

WHEREAS, on said application, Applicant disclosed a January 9, 2009, conviction for Unlawful Imprisonment, a Class 1 Misdemeanor, in the State of Arizona, where judgement was deferred with Applicant's plea of guilty;

WHEREAS, on February 11, 2009, Applicant was sentenced to two (2) years of probation and discharged on February 9, 2011;

WHEREAS, on May 16, 2016, the Superior Court of Arizona, County of Maricopa, issued an order setting aside Applicant's judgement of guilt, dismissing the accusations, and releasing Applicant from all penalties and disabilities resulting from Applicant's Unlawful Imprisonment conviction;

WHEREAS, Indiana Code § 27-1-15.6-12(b)(8) states, in part, that the Commissioner may levy a civil penalty and place a producer on probation for using fraudulent, coercive, or dishonest practices, or demonstrating incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in Indiana or elsewhere; and

WHEREAS, the Department and Applicant (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the Parties as follows:

- 1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. In order to avoid formal litigation in this matter, Applicant has determined that it is in his best interest to enter into this Agreed Entry. As such Applicant acknowledges that he executes this Agreed Entry with full realization of its contents and effects.

- 3. This Agreed Entry is executed knowingly, voluntarily, and freely by the Parties. The Parties agree that the terms of this Agreed Entry constitute final resolution of this matter.
- 4. Applicant knowingly, voluntarily and freely waives the right to a public hearing on this matter, including the right to appear in person before the Commissioner, present evidence, cross-examine witnesses, and present arguments.
- 5. Applicant knowingly, voluntarily and freely waives the right to judicial review of this matter or otherwise appeal or challenge the validity of this Agreed Entry.
- 6. Applicant knowingly, voluntarily and freely waives, releases, and forever discharges all claims or challenges, known or unknown, against the Department, its Commissioner, employees, agents, and representatives, in their individual and official capacities, that arise out of or are related to the Agreed Entry or Final Order, including but not limited to any act or omission as part of the underlying audit, investigation, negotiation, or approval process.
- 7. Applicant's nonresident producer license shall be approved, and Applicant shall be placed on probation for a period of one (1) year, beginning the date the Commissioner signs the Final Order adopting this Agreed Entry.

 During the probationary period, any violation of Title 27 of the Indiana Code will result in the Department seeking immediate revocation of Applicant's license.

- 8. Applicant shall pay a civil penalty in the amount of two hundred fifty dollars (\$250) to the Department within thirty (30) days after the Commissioner signs the Final Order adopting this agreed entry.
- Applicant has carefully read and examined this Agreed Entry and fully understands its terms.
- 10. Applicant has had the opportunity to have this Agreed Entry reviewed by legal counsel of his choosing, at his own expense, and is aware of the benefits gained and obligations incurred by the execution of this Agreed Entry. Applicant understands and agrees that the Department cannot give him legal advice.
- 11. Applicant has entered into this agreement freely, and has not been subject to duress, coercion, threat, or undue influence.
- 12. This Agreed Entry constitutes the entire agreement between the Parties, and no other promises or agreements, express or implied, have been made by the Department or by any employee, director, agent, or other representative thereof to induce Applicant to enter this Agreed Entry.
- 13. The Department agrees to accept Applicant's compliance with the terms of this Agreed Entry as full satisfaction of this matter, and warrants a represents that so long as Applicant complies with the terms of this Agreed Entry, the Department will not bring any further action against Applicant based on the facts that gave rise to this Agreed Entry.
- 14. In the event the Department finds there has been a breach of any provision of this Agreed Entry, the Department may reopen this matter and pursue alternative action pursuant to Indiana Code § 27-1-15.6-12.

- 15. Applicant waives any applicable statute of limitations for purposes of any enforcement of the terms and conditions of this Agreed Entry.
- 16. Applicant acknowledges that this Agreed Entry may be admitted into evidence in any judicial or administrative proceeding against Applicant to enforce the terms and conditions contained herein.
- 17. Applicant understands that this Agreed Entry resolves only the matter pending with the Department and does not affect any criminal prosecution or civil litigation that may be pending or hereinafter commence against Applicant.
- 18. This Agreed Entry does not in any way affect the Department's authority in future audits, investigations, examinations, negotiations, or other complaints involving Applicant.
- 19. It is expressly understood that this Agreed Entry is subject to the Commissioner's acceptance and has no force or effect until such acceptance is evidenced by the entry of a Final Order by the Commissioner.
- 20. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to, and consideration of this Agreed Entry by the Commissioner, shall not unfairly or illegally prejudice the Commissioner or Applicant from further participation in or resolution of these proceedings.
- 21. If this Agreed Entry is accepted by the Commissioner, it will become part of Applicant's permanent record and may be considered in future actions brought by the Department or any other regulator against Applicant. It is further understood that, if accepted by the Commissioner, the Agreed Entry

and resulting Final Order are public records pursuant to Indiana Code § 4-21.5-3-32 that may not be sealed or otherwise withheld from the public, and may be reported to the National Association of Insurance Commissioners, and published on the Department's website as required.

22. Applicant acknowledges that this is an Administrative Action and that he may be required to report to other jurisdictions in which he is licensed and on future applications.
