ADMINISTRATIVE ORDER NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 et seq., and Indiana Code § 27-1-15.6-12, hereby gives notice to Group Underwriters Agency, Inc. ("Respondent") of the following Administrative Order:

- 1. Respondent is a nonresident licensed insurance producer organization holding license number 62266 ("Respondent's license") since November 7, 2003.
- 2. Respondent's license will expire on January 31, 2020.
- 3. Respondent submitted an application to renew their license on November 14, 2019.
- 4. On said application, Respondent disclosed that Respondent's owner, Charles Ferrell Long, Jr., was convicted on or about February 19, 2013, on two (2) counts of Possession of Child Pornography, a Class 4 Felony.
- 5. On said application, Respondent disclosed an August 15, 2019, the California Department of Insurance revoked Respondent's nonresident producer organization license

- due to Mr. Long's felony convictions, and for failing to disclose the same on their renewal application.
- 6. Indiana Code § 27-1-15.6-12(b)(8) states, in part, the Commissioner may refuse to renew an insurance producer license for using fraudulent, coercive, or dishonest practices, or demonstrating incompetence, untrustworthiness, or financial responsibility in the conduct of business in Indiana or elsewhere.
- 7. Indiana Code § 27-1-15.6-12(b)(9) states, in part, the Commissioner may refuse to renew an insurance producer license for having an insurance producer license, or its equivalent, denied, suspended, or revoked in any other state, province, district, or territory
- 8. Indiana Code § 27-1-15.6-12(d) provides that when the Commissioner refuses to renew a license, the Commissioner shall notify the Respondent, in writing, of the reasons for the nonrenewal. This Order serves as that notice.
- 9. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies
Respondent that **Respondent's license shall not be renewed** for having a license revocation in another state.
