

**MOTION TO LIFT SUSPENSION ORDER**


The Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Victoria Hastings, now moves that the Suspension Order issued on August 10, 2018, in this matter be lifted. In support of this request the Department asserts the following:

1. Christopher Byrd (“Respondent”) is a licensed nonresident insurance producer holding license #3312215.
2. On June 21, 2018, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a letter requesting a list of appointments.
3. More than ten (10) days elapsed after the Commissioner requested a list of appointments without a response from Respondent.
4. On July 6, 2018, the Commissioner mailed a second letter to the Respondent, requesting a list of appointments.
5. More than ten (10) days elapsed after the Commissioner’s second request for a list of appointments without a response from Respondent.

6. Pursuant to Indiana Code § 27-1-15.6-12(g), on August 10, 2018, the Commissioner issued a Suspension Order suspending Respondent's license until such a time as the Commissioner received Respondent's list of appointments.
7. On March 23, 2020, Respondent sent an email to the Department providing a list of his appointments.

WHEREFORE, the Department requests that the Commissioner issue an order lifting the suspension of Respondent's license and all other relief just and proper upon the premise.

**FINDINGS OF FACT AND SUSPENSION ORDER**

WHEREAS, Christopher Byrd (“Respondent”) is a nonresident insurance producer holding license number 3312215;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request, within ten (10) days of receiving a request;

WHEREAS, on June 21, 2018, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a letter requesting a list of appointments and a written response to a complaint received by the Department;

WHEREAS, the letter was mailed to 6909 Shannon Dr., Apt 1331, Charlotte, NC 28270, Respondent’s address of record with the Department.

WHEREAS, on July 6, 2018, a second letter requesting a list of appointments and a written response was mailed to the Respondent at the Respondent's address of record;

WHEREAS, neither letter was returned to the Commissioner as undeliverable;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 3312215 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments as requested by the Commissioner.
