PRELIMINARY ADMINISTRATIVE ORDER
AND NOTICE OF LICENSE DENIAL

The Indiana Department of Insurance, pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.* and Indiana Code § 27-1-15.6-12, hereby gives notice to Eddie Junior Brown ("Applicant") of the following Administrative Order:

1. Applicant filed an application for nonresident producer licensure with the Commissioner of the Indiana Department of Insurance ("Commissioner") on February 15, 2020.
2. Before approving an application, the Commissioner must find that the applicant has met specific requirements under Indiana Code § 27-1-15.6-8 and Indiana Code § 27-1-15.6-12.
3. Indiana Code § 27-1-15.6-12(b)(1) provides, in part, that the Commissioner may refuse to issue an insurance producer license for providing incorrect, misleading, incomplete or materially untrue information in a license application.
4. Indiana Code § 27-1-15.6-12(b)(7) provides, in part, that the Commissioner may refuse to issue an insurance producer license for admitting to having committed or being found to have committed any unfair trade practice or fraud in the business of insurance.

5. Indiana Code § 27-1-15.6-12(b)(8) provides, in part, that the Commissioner may refuse to issue an insurance producer license for using fraudulent, coercive, or dishonest practices, or demonstrating incompetence, untrustworthiness or financial irresponsibility in the conduct of business in Indiana or elsewhere.
6. Indiana Code § 27-1-15.6-12(b)(9) provides, in part, that the Commissioner may refuse to issue an insurance producer license for having an insurance producer license, or its equivalent, denied, suspended, or revoked in any other state, province, district, or territory.
7. Following a review of public records, the Commissioner being fully advised, now hereby notifies Applicant he has not fully met the requirements of licensure as stated by Indiana Codes §§ 27-1-15.6-12(b)(1), 27-1-15.6-12(b)(7), and 27-1-15.6-12(b)(8) based on Applicant's criminal history, which includes a September 6, 2007, conviction for Disorderly Conduct, a violation; and a May 19, 2009, conviction for Insurance Fraud in the Fifth Degree, a Class A Misdemeanor, both from New York, and also for Applicant's failure to disclose the same on his application for licensure.
8. Following a review of public records, the Commissioner being fully advised, now hereby notifies Applicant that he has not fully met the requirements of licensure as stated by Indiana Code § 27-1-15.6-12(b)(1) for failing to disclose a March 22, 2012 Georgia License Reinstatement Consent Order.
9. Following a review of public records, the Commissioner being fully advised, now hereby notifies Applicant that he has not fully met the requirements of licensure as stated by Indiana Code § 27-1-15.6-12(b)(1) and Indiana Code 27-1-15.6-12(b)(9) for failing to disclose the following administrative actions, and failing to disclose the same on his application for licensure:


- a. February 2, 2011, New York License Revocation;
 - b. December 11, 2007, Connecticut License Denial;
 - c. March 16, 2018, Indiana License Denial;
 - d. June 1, 2018, South Dakota License Denial;
 - e. September 13, 2018, Connecticut License Denial;
 - f. August 24, 2018, Illinois License Denial; and
 - g. January 30, 2019, Idaho License Revocation
10. Indiana Code § 27-1-15.6-12(d) provides that the applicant may, not more than sixty-three (63) days after notice of denial of the application is mailed, make written demand to the Commissioner for a hearing before the Commissioner to determine the reasonableness of the Commissioner's action.

IT IS THEREFORE ORDERED that Applicant's request for licensure is hereby **DENIED** pursuant to Indiana Codes §§ 27-1-15.6-12(b)(1), 27-1-15.6-12(b)(7), 27-1-15.6-12(b)(8), and 27-1-15.6-12(b)(9) due to Applicant's criminal history, including a conviction for insurance fraud,

and for Applicant's failure to disclose the same on his application for licensure, as well as Applicant's multiple administrative actions, including two license revocations, and Applicant's failure to disclose the same on his application for licensure.
