FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS Tyler Searcy (“Respondent”) is a nonresident insurance producer holding license number 3517552 since January 30, 2020;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request, within ten (10) days of receiving a request;

WHEREAS, on June 16, 2020, the Commissioner of the Indiana Department of Insurance (“Commissioner”) sent Respondent a letter requesting a list of appointments to Respondent’s most recent email address of record;

WHEREAS, this letter was not returned to the Commissioner as “undeliverable” or otherwise;

WHEREAS, on June 23, 2020, the Commissioner mailed Respondent a certified mail article #7017 2620 0000 5742 0395 requesting a list of appointments to Respondent’s address of record;

WHEREAS, on or about June 25, 2020, certified mail article 7017 2620 0000 5742 0395 was returned to the Department as “undeliverable,” and according to the USPS Tracking website for this

certified mail article; it stated that the "addressee was not known at the delivery address noted on the package";

WHEREAS, Indiana Code § 27-1-15.6-12(b)(17) provides that the Commissioner may suspend an insurance producer's license for failing to timely inform the Commissioner of a change in address in violation of Indiana Code § 27-1-15.6-7(h);

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;


WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days and failure to provide a change of address within thirty (30) days after the change constitutes a violation of Indiana Codes §§ 27-1-15.6-12(g) and 27-1-15.6-12(b)(17); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license #3517552 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
