FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, James Mieczkowski (“Respondent”) is a nonresident insurance producer holding license #3251127 since February 20, 2020;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner of the Indiana Department of Insurance (“Commissioner”) with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on June 26, 2020, the Commissioner mailed to Respondent using United State Postal Services a mail article requesting a list of appointments to Respondent’s address of record;

WHEREAS, on July 24, 2020, the Commissioner mailed Respondent a certified mail article # 7016 2070 0001 1480 0971 requesting a list of appointments to Respondent’s address of record;

WHEREAS, on August 12, 2020, certified mail article # 7016 2070 0001 1480 0971 was returned to the Department, which was marked as “Not Deliverable, unable to forward”, at Respondent’s address of record;

WHEREAS, Indiana Code § 27-1-15.6-12(b)(17) provides that the Commissioner may suspend an insurance producer's license for failing to timely inform the Commissioner of a change in address in violation of Indiana Code § 27-1-15.6-7(h);

WHEREAS, Respondent has failed to provide a change of address to the Commissioner within thirty (30) days after the change;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days and failure to provide a change of address within thirty (30) days after the change constitutes a violation of Indiana Codes §§ 27-1-15.6-12(g) and 27-1-15.6-12(b)(17); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license #3521127 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
