

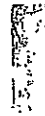

STATEMENT OF CHARGES

The Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Victoria Hastings, pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5 *et seq.*, files its Statement of Charges against Matthew Marques (“Respondent”), as follows:

FACTS

1. Matthew Marques (“Respondent”) is a nonresident insurance producer, holding license #3417213 since February 21, 2019.
2. On or about June 20, 2019, Respondent was terminated for cause from Freedom Life Insurance Company of America (“Freedom”).
3. On or about June 26, 2019, the Indiana Department of Insurance (“Department”) received the letter of termination for Respondent from Freedom for deliberate misrepresentations and submitting incomplete or materially untrue applications for health insurance.

4. On or about May 11, 2019, Respondent was texting a potential client, marketing a product that was not available in her state and suggests that she allow Respondent to submit the application using his address instead of her own in order to push it through.

CHARGES

COUNT I

1. Averments 1 through 4 are incorporated fully herein by reference.
2. Indiana Code § 27-1-15.6-12(b)(2)(A) states the Commissioner may revoke an insurance producer license for violating an insurance law.
3. Respondent's conduct as alleged herein is a violation of Indiana Code § 27-1-15.6-12(b)(8), which is an insurance law, that states a producer shall not use fraudulent, coercive, or dishonest practices, or demonstrate incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in Indiana or elsewhere.


COUNT II

1. Averments 1 through 4 are incorporated fully herein by reference.
2. Indiana Code § 27-1-15.6-12(b)(2)(A) states the Commissioner may revoke an insurance producer license for violating an insurance law.
3. Respondent's conduct as alleged herein is a violation of Indiana Code § 27-1-15.6-12(b)(5), which is an insurance law, that states a producer shall not intentionally misrepresent the terms of an actual proposed insurance contract or application for insurance.

WHEREFORE, the Enforcement Division of the Indiana Department of Insurance, by counsel, Victoria Hastings, requests that the Commissioner set this matter for a hearing pursuant to Indiana Code § 4-21.5, and:

- (1) Issue an order permanently revoking Respondent's nonresident insurance producer license #3417213; and
- (2) Grant all other relief necessary and proper in the premises.
