
ORDER LIFTING SUSPENSION

MOTION TO LIFT SUSPENSION


The Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Victoria Hastings, now moves that the Suspension Order issued on December 5, 2019, in this matter be lifted. In support of this request, the Department asserts the following:

1. Steven D. Zitomer ("Respondent") is a nonresident insurance producer under license number 737635;
2. On October 17, 2019, a letter was mailed to Respondent by regular mail via the United States Postal Services requesting a list of appointments;
3. On November 1, 2019, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a certified letter requesting a list of appointments;
4. On November 7, 2019, certified mail article # 7005 3110 0002 4441 8624, was returned to the Department marked "Return to Sender/Unclaimed/Unable to Forward;"
5. More than ten (10) days had elapsed since the Commissioner requested a list of appointments without a response from Respondent;

6. Pursuant to Indiana Code § 27-1-15.6-12(g), on December 5, 2019, the Commissioner issued a Suspension Order suspending Respondent's license #737635 until such time as the Commissioner received Respondent's list of appointments;
7. On February 7, 2020, Respondent sent an email to the Department providing a list of their appointments.

WHEREFORE, the Department respectfully requests that the Commissioner issue an order lifting the suspension of Respondent's license and for all other relief just and proper in the premises.

FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Steven D Zitomer ("Respondent") is a nonresident insurance producer holding license #737635 since January 14, 2011;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer must furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on October 17, 2019, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a letter requesting a list of appointments via USPS First Class Mail to Respondent's address of record;

WHEREAS, said letter was not returned to the Commissioner as "undeliverable" or otherwise;

WHEREAS, on November 1, 2019, the Commissioner mailed Respondent a certified mail article # 7005 3110 0002 4441 8624 requesting a list of appointments to Respondent's address of record;

WHEREAS, on November 7, 2019, certified mail article # 7005 3110 0002 4441 8624 was returned to the Department marked "Return to Sender/Unclaimed/Unable to Forward;"

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license #737635 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
