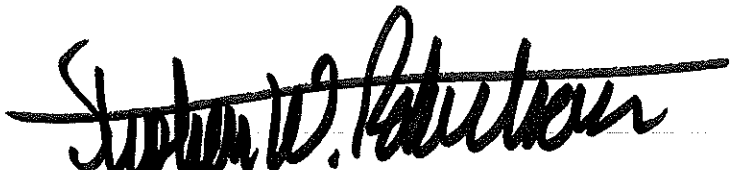

4. On June 18, 2020 the Commissioner also sent a request for a list of appointments to Respondent via email to the email address on record for Respondent.
5. More than ten (10) days elapsed since the Commissioner requested a list of appointments without a response from Respondent.

**FINDINGS OF FACT AND SUSPENSION ORDER**

WHEREAS, Jeridy De La Rosa ("Respondent") is a nonresident insurance producer holding license number 3228199;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request, within ten (10) days of receiving a request;

WHEREAS, on June 9, 2020, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a letter via certified mail article # 7017 3040 0000 9294 3207 requesting a list of appointments to Respondent's address of record;

WHEREAS, on June 16, 2020, certified mail article # 7017 3040 0000 9294 3207 was returned to the Department by the United States Postal Service, and marked as "return to sender";

WHEREAS, on June 18, 2020, the Commissioner also sent request for a list of appointments to Respondent via email to the email address on record for Respondent;

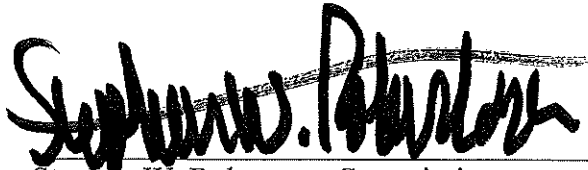
WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

**IT IS THEREFORE ORDERED BY THE COMMISSIONER** that Respondent's nonresident insurance producer license number 3228199 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
