**ADMINISTRATIVE ORDER AND
NOTICE OF NONRENEWAL OF LICENSE**

The Indiana Department of Insurance (“Department”), pursuant to Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.*, and Indiana Code § 27-1-15.6-12, hereby gives notice to Brandon A. Lewandowski, (“Respondent”) of the following Administrative Order:

1. Respondent is a licensed nonresident insurance producer holding license number 3166408 since June 23, 2016 (“Respondent’s license”).
2. Respondent’s license expired on August 31, 2020.
3. On or about July 22, 2020, it was discovered that on Respondent’s July 16, 2018 application for renewal Respondent failed to timely report and failed to disclose his May 21, 2018 criminal charge for Domestic Violence, a First Degree Misdemeanor, wherein Respondent was later convicted of the amended charge of Disorderly Conduct, a Fourth Degree Misdemeanor.

11. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of his license. This Order serves as that notice.

12. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

13. This is considered an agency action. This action has been initiated by the aforementioned authority. If you choose to appeal this agency action, the State of Indiana Office of Administrative Law Proceedings ("OALP") will assign an administrative law judge to preside over this matter, and subsequently you will be contacted by the OALP with more information to begin the administrative process.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that **his license shall not be renewed** due to his failure to disclose his criminal proceedings in an application, and due to his failure to timely report his criminal proceedings and an administrative action the Department.
