**FINDINGS OF FACT AND SUSPENSION ORDER**

WHEREAS, Ryan Lewis ("Respondent") is a nonresident insurance producer holding license #1038828 since June 1, 2015;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on November 10, 2020, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a letter requesting a list of appointments via USPS First Class Mail to Respondent's address of record;

WHEREAS, said letter was not returned to the Commissioner as "undeliverable" or otherwise;

WHEREAS, on December 3, 2020, the Commissioner mailed Respondent a letter via certified mail article # 7016 2070 0001 1480 1183 requesting a list of appointments to Respondent's address of record;

WHEREAS, on December 7, 2020, certified mail article # 7016 2070 0001 1480 1183 was marked as "Delivered" to Respondent at Respondent's address of record;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

**IT IS THEREFORE ORDERED BY THE COMMISSIONER** that Respondent's license #1038828 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
