**FINDINGS OF FACT AND SUSPENSION ORDER**

WHEREAS, Daniel Pryor (“Respondent”) is a nonresident insurance producer holding license number 587806;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request, within ten (10) days of receiving a request;

WHEREAS, on February 10, 2021, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a letter via certified mail article # 7018 1130 0001 7980 2950 requesting a list of appointments to Respondent’s address of record;

WHEREAS, on February 27, 2021, certified mail article # 7018 1130 0001 7980 2950 was successfully delivered to Respondent at Respondent’s address of record by the United States Postal Service;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner’s request;


WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

**IT IS THEREFORE ORDERED BY THE COMMISSIONER** that Respondent's license number 587806 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
