FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Brandon J Novak (“Respondent”) is a resident insurance producer holding license #772375 since August 26, 2011;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on August 7, 2020, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a letter requesting a list of appointments via USPS First Class Mail to Respondent’s address of record;

WHEREAS, said letter was not returned to the Commissioner as “undeliverable” or otherwise;

WHEREAS, on October 22, 2020, the Commissioner mailed Respondent a certified mail article # 7016 2070 0001 1480 1107 requesting a list of appointments to Respondent’s address of record;

WHEREAS, on October 27, 2020, certified mail article # 7016 2070 0001 1480 0902 was marked "Insufficient Address;"

WHEREAS, on December 3, 2020, the Commissioner e-mailed Respondent a letter requesting a list of appointments to Respondent's e-mail address of record;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.


IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license #772375 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
