## PRELIMINARY ADMINISTRATIVE ORDER AND NOTICE OF LICENSE DENIAL

The Indiana Department of Insurance, pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.* and Indiana Code § 27-1-15.6-12, hereby gives notice to James Adger ("Applicant") of the following Administrative Order:

- 1. Applicant filed an application for nonresident producer licensure with the Commissioner of the Indiana Department of Insurance ("Commissioner") on January 12, 2021.
- 2. Before approving an application, the Commissioner must find that the applicant has met specific requirements under Indiana Code § 27-1-15.6-8 and Indiana Code § 27-1-15.6-12.
- 3. Indiana Code § 27-1-15.6-12(b)(1) provides, in part, that the Commissioner may refuse to issue an insurance producer license for providing incorrect, misleading, incomplete, or materially untrue information in a license application.
- 4. Indiana Code § 27-1-15.6-12(b)(8) provides, in part, that the Commissioner may refuse to issue an insurance producer license for using fraudulent, coercive, or dishonest practices,

- or demonstrating incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in Indiana or elsewhere.
- 5. Indiana Code § 27-1-15.6-12(b)(9) provides, in part, that the Commissioner may refuse to issue an insurance producer license for having an insurance producer license, or its equivalent, denied, suspended, or revoked in any other state, province, district, or territory.
- 6. Following a review of public records and the materials submitted by Applicant in support of his application, the Commissioner being fully advised, now hereby notifies Applicant that he has not fully met the requirements of licensure as stated by Indiana Codes §§ 27-1-15.6-12(b)(1), 27-1-15.6-12(b)(8) due to Applicant's criminal history and failure to disclose the same on his application for licensure, specifically, Applicant's February 12, 2001 conviction for Possession of Marijuana, a Class A Misdemeanor.
- 7. Following a review of public records and the materials submitted by Applicant in support of his application, the Commissioner being fully advised, now hereby notifies Applicant that he has not fully met the requirements of licensure as stated by Indiana Codes § 27-1-15.6-12(b)(9) due to Applicant's following administrative actions, which include multiple license denials and multiple license revocations:
  - a. on July 18, 2008, Applicant's nonresident producer's license was denied in
    Wisconsin due to a failure to make required disclosure on an application;
  - b. on December 4, 2013, Applicant's nonresident producer's license was denied in Wisconsin for failing to make required disclosure on application and for a late or incomplete response;

- c. on August 16, 2014, Applicant's nonresident producer's license was denied in
  Colorado due to a failure to make required disclosure on license application;
- d. on March 1, 2015, North Carolina Department of Insurance had a complaint filed and in their investigation they discovered Applicant's denials and revocations of his licenses from other states. Applicant settled with North Carolina via a voluntary surrender of Applicant's nonresident producer's license;
- e. on June 10, 2015, California revoked Applicant's nonresident producer's license due to other state administrative actions and failure to respond;
- f. on September 30, 2015, Missouri agreed to a voluntary surrender of Applicant's nonresident producer's license due to failure to report other state actions and a complaint investigation;
- g. on November 9, 2018, Indiana denied Applicant's application for a nonresident producer's license due to a failure to report other state actions;
- n. on November 22, 2019, Indiana denied Applicant's application for nonresident producer's license due to failure to report other state actions;
- i. on February 7, 2020, Louisiana revoked his nonresident producer's license for failure to report other state actions; and
- j. on October 16, 2020, North Carolina revoked his nonresident producer's license for failure to report other state actions.
- 8. Indiana Code § 27-1-15.6-12(d) provides that the applicant may, not more than sixty-three (63) days after notice of denial of the application is mailed, make written demand to the

Commissioner for a hearing before the Commissioner to determine the reasonableness of

the Commissioner's action.

This is considered an agency action. This action has been initiated by the aforementioned 9.

authority. If you choose to appeal this agency action, the State of Indiana Office of

Administrative Law Proceedings ("OALP") will assign an administrative law judge to

preside over this matter, and subsequently you will be contacted by the OALP with more

information to begin the administrative process.

IT IS THEREFORE ORDERED that Applicant's request for licensure is hereby DENIED

pursuant to Indiana Codes §§ 27-1-15.6-12(b)(1), 27-1-15.6-12(b)(8) and 27-1-15.6-12(b)(9) due

to Applicant's multiple administrative actions, which involved multiple license revocations and

license denials, and for Applicant's failure to disclose a 2001 misdemeanor. Applicant may

reapply for licensure not less than one (1) year from the date of this order.
