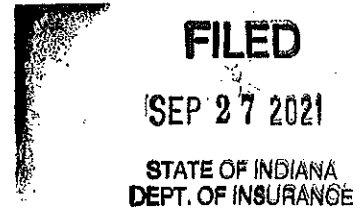

### FINDINGS OF FACT, CONCLUSIONS OF LAW

### AND RECOMMENDED ORDER

---

Administrative Law Judge Reuben B. Hill ("ALJ"), having heard, reviewed and considered  
all of the evidence, now renders a decision concerning the matter of Tarpeh Walker.  
("Petitioner").

This matter came to be heard by ALJ on April 20, 2021, at 10:00 a.m. via audio  
conferencing. Petitioner appeared telephonically, and without counsel. Enforcement Division of

the Indiana Department of Insurance ("Department") was represented by counsel, Victoria Hastings. Testimony was heard, and exhibits were received into evidence.

Based upon the evidence presented at said hearing, the ALJ now makes the following Findings of Fact, Conclusions of Law, and issues his Recommended Order.

### **FINDINGS OF FACT**

1. Petitioner submitted his application for a Resident Producer License on December 8, 2020. (Department's Exhibit 1)
2. Petitioner answered "yes" to the application question that asks "Have you ever been convicted of a misdemeanor?" (Department's Exhibit 1)
3. Petitioner answered "yes" to criminal history and failed to upload the corresponding documents relating to his criminal conviction.
4. Petitioner was convicted of Theft, a Class A Misdemeanor, on November 21, 2019, in Indiana. (Department's Exhibits 2, 3)
5. Petitioner failed to fully disclose his criminal history on his application to the Department. (Department's Exhibits 1,2)
6. Petitioner was denied license due to his theft conviction and for his failure to fully disclose it on his application for license. (Departments Exhibits 1, 2)
7. Petitioner testified at the hearing that when he was filling out the application, it was his first time going through this process and did not intend to deceive the Department.
8. Petitioner testified that he did upload documentation concerning his criminal history.
9. Petitioner had a character reference, a Ms. Amanda Peterson, testify at the hearing.
10. Ms. Peterson testified that Petitioner has been extremely respectful and on time.
11. Ms. Peterson testified that Petitioner has been an exemplary citizen.
12. Petitioner testified that he is enrolled in business classes at Ivy Tech and will be graduating December 2021.
13. Petitioner was approximately nineteen (19) years old at the time of committing the offense. (Department's Exhibit 1,3)
14. Petitioner is now approximately twenty-three (23) years old. (Department's Exhibit 1)

15. Conclusions of Law that can be adopted as Findings of Fact are hereby incorporated herein as such.

### **CONCLUSIONS OF LAW**

1. The Commissioner of the Indiana Department of Insurance ("Commissioner") has jurisdiction over both the subject matter and the parties to this action.
2. This hearing was held in compliance with the Administrative Orders and Procedures Act of the Indiana Code.
3. Indiana Code 27-1-15.6-12(b) states that the Commissioner may refuse to issue an Insurance Producer License, due to a number of factors.
4. Indiana Code 27-1-15.6-12(b)(1) allows the Commissioner to deny an Insurance Producer License for providing incorrect, misleading, incomplete, or materially untrue information in a license application.
5. Indiana Code 27-1-15.6-12(b)(8) allows the Commissioner to deny an Insurance Producer License for using fraudulent, coercive, or dishonest practices, or demonstrating incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in Indiana or elsewhere.
6. Petitioner failed to fully disclose his criminal history on his application for license. Facts in mitigation include Petitioner's remorseful and sincere demeanor, Petitioner's youth at the time the offense occurred, the age of the conviction, and the fact that Petitioner's answer, "yes" on the application regarding his criminal history.
7. Indiana Code 4-21.5-3-14(c) states that the person requesting an agency take action has the burden of persuasion and the burden of going forward. Petitioner is requesting that the Department issue him a Resident Producer License and, therefore, bears the burden.
8. Pursuant to Indiana Code 27-1-15.6-12(d), a hearing was held to determine the reasonableness of the Commissioner's decision, due to mitigating factors, Petitioner should be granted a license.
9. Findings of Fact that can be adopted as Conclusions of Law are hereby incorporated herein as such.

### **RECOMMENDED ORDER**

**IT IS THEREFORE RECOMMENDED:**

In consideration of the foregoing, Findings of Fact and the Conclusions of Law as stated, the Administrative Law Judge now recommends to the **Commissioner of Insurance** the following:

1. That Petitioner's application under License Application Number 832215 for an Indiana Resident Producer License should be **GRANTED**.

**ALL OF WHICH IS FOUND** by the Administrative Law Judge and recommended to the **Commissioner of Insurance** on June 30, 2021. **This recommended order is not final.**

**This matter is now before the ultimate authority, the Commissioner of Insurance who has the final authority over this matter and shall review this recommended order then issue a final order to all parties.**

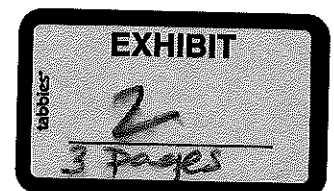

**PRELIMINARY ADMINISTRATIVE ORDER**  
**AND NOTICE OF LICENSE DENIAL**

The Indiana Department of Insurance, pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.* and Indiana Code § 27-1-15.6-12, hereby gives notice to Tarpeh Walker ("Applicant") of the following Administrative Order:

1. ~~Applicant filed an application for resident producer licensure with the Commissioner of~~  
the Indiana Department of Insurance ("Commissioner") on December 9, 2020.
2. Before approving an application, the Commissioner must find that the applicant has met  
specific requirements under Indiana Code § 27-1-15.6-6 and Indiana Code § 27-1-15.6-12.
3. Indiana Code § 27-1-15.6-12(b)(1) provides, in part, that the Commissioner may refuse to  
issue an insurance producer license for providing incorrect, misleading, incomplete, or  
materially untrue information in a license application.
4. Indiana Code § 27-1-15.6-12(b)(8) provides, in part, that the Commissioner may refuse to  
issue a producer license for using fraudulent, coercive, or dishonest practices, or




demonstrating incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in Indiana or elsewhere.

5. Following a review of materials submitted by Applicant in support of his application, the Commissioner being fully advised, now hereby notifies Applicant that he has not fully met the requirements of licensure as stated by Indiana Code § 27-1-15.6-12(b)(1) due to Applicant's failure to disclose a November 21, 2019, conviction for Theft, a Class A Misdemeanor.
6. Following a review of materials submitted by Applicant in support of his application, the Commissioner being fully advised, now hereby notifies Applicant that he has not fully met the requirements of licensure as stated by Indiana Codes § 27-1-15.6-12(b)(8) due to Applicant's criminal history, which includes a November 21, 2019, conviction for Theft, a Class A Misdemeanor.
7. Indiana Code § 27-1-15.6-12(d) provides that the applicant may, not more than sixty-three (63) days after notice of denial of the application is mailed, make written demand to the Commissioner for a hearing before the Commissioner to determine the reasonableness of the Commissioner's action.
8. This is considered an agency action. This action has been initiated by the aforementioned authority. If you choose to appeal this agency action, the State of Indiana Office of Administrative Law Proceedings ("OALP") will assign an administrative law judge to preside over this matter, and subsequently you will be contacted by the OALP with more information to begin the administrative process.

**IT IS THEREFORE ORDERED** that Applicant's request for licensure is hereby **DENIED** pursuant to Indiana Codes §§ 27-1-15.6-12(b)(1) and 27-1-15.6-12(b)(8) due to Applicant's criminal history, which includes a recent conviction for a crime of dishonesty, and for Applicant's failure to disclose the same. Applicant may reapply for licensure not less than one (1) year from the date of this order.
