**MOTION TO LIFT SUSPENSION**


The Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Victoria Hastings, now moves that the Suspension Order issued on March 22, 2021, in this matter be lifted. In support of this request, the Department asserts the following:

1. Earl Wingfield ("Respondent") is a nonresident insurance producer holding license #3407389 since January 11, 2019;
2. On January 21, 2021, a letter was mailed to Respondent by regular mail via the United States Postal Services requesting a list of appointments;
3. On February 8, 2021, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a certified letter requesting a list of appointments;
4. More than ten (10) days elapsed since the Commissioner requested a list of appointments without a response from Respondent;
5. Pursuant to Indiana Code § 27-1-15.6-12(g), on March 22, 2021, the Commissioner issued a Suspension Order suspending Respondent's license #3407389 until such time as the Commissioner received Respondent's list of appointments;

6. On August 26, 2021, Respondent sent an email to the Department providing a list of their appointments.

WHEREFORE, the Department respectfully requests that the Commissioner issue an order lifting the suspension of Respondent's license, and for all other relief just and proper in the premises.

**FINDINGS OF FACT AND SUSPENSION ORDER**

WHEREAS, Earl Wingfield ("Respondent") is a nonresident insurance producer holding license #3407389 since January 11, 2019;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on January 21, 2021, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a letter requesting a response to resolve the matter via USPS First Class Mail to Respondent's address of record;

WHEREAS, said letter was returned to the Commissioner as "unable to forward";

WHEREAS, on February 8, 2021, the Commissioner mailed Respondent letter via certified mail article # 7018 1130 0001 7980 2554 requesting a list of appointments to Respondent's address of record;

WHEREAS, on February 11, 2021, certified mail article # 7018 1130 0001 7980 2554 was marked as "vacant/unable to forward;"

WHEREAS, on February 19, 2021, certified mail article # 7018 1130 0001 7980 2554 was returned to the Department;

WHEREAS, Indiana Code § 27-1-15.6-12(b)(17) provides that the Commissioner may suspend an insurance producer's license for failing to timely inform the Commissioner of a change in address in violation of Indiana Code § 27-1-15.6-7(h);

WHEREAS, Respondent has failed to provide a change of address to the Commissioner within thirty (30) days after the change;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days and failure to provide a change of address within thirty (30) days after the change constitutes a violation of Indiana Codes §§ 27-1-15.6-12(g) and 27-1-15.6-12(b)(17); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license #3407389 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
