**FINDINGS OF FACT AND SUSPENSION ORDER**

WHEREAS, Evan P Navarro (“Respondent”) is a nonresident insurance producer holding license #3372373 since September 10, 2018;

WHEREAS, Indiana Code § 27-1-15.6-8(f) states, in part, that a licensed nonresident producer who receives a nonresident producer license shall maintain licensure in good standing in the nonresident producer’s home state;

WHEREAS, Indiana Code § 27-1-15.6-8(b) states that the Commissioner of the Indiana Department of Insurance (“Commissioner”) may verify a producer’s licensing status through the Producer Database maintained by the National Association of Insurance Commissioners (“NAIC”) and its affiliates or subsidiaries;

WHEREAS, on or about May 12, 2021, the Commissioner verified through the Producer Database maintained by the NAIC that Respondent’s producer license in his home state of Kansas was no longer active as of April 8, 2021 and is no longer in effect as required under Indiana Code § 27-1-15.6-8(f);


WHEREAS, specifically, on or about April 8, 2021, Respondent's home state license in Kansas was revoked due to Respondent's conviction from February 20, 2020 for Theft, a Misdemeanor; and Unlawful Discharge of a Firearm, a Misdemeanor;

WHEREAS, Indiana Code § 27-1-15.6-8(g) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any Indiana insurance producer license held by the nonresident producer until the Commissioner receives notice from the nonresident producer's home state that the home state license is in effect.

**IT IS THEREFORE ORDERED BY THE COMMISSIONER** that Respondent's license #3372373 is hereby suspended, effective immediately, and will remain suspended until the Commissioner receives notice from Respondent's home state that his home state license is in effect.
