MOTION TO LIFT SUSPENSION ORDER


The Indiana Department of Insurance Enforcement Division (“Department”), by counsel, Victoria Hastings, now moves for the Suspension Order of June 14, 2021 be lifted. In support of this request the Department asserts the following:

1. Adroit Health Group, LLC (“Respondent”) is a nonresident insurance producer organization under license #3167070.
2. On April 13, 2021, the Commissioner mailed Respondent a certified letter requesting a list of appointments to Respondent’s address of record.
3. On April 19, 2021, certified mail article # 7018 1130 0001 7980 2974 was successfully delivered by the United States Postal Service.
4. More than ten (10) days elapsed since the Commissioner requested a list of appointments without a response from Respondent.
5. Pursuant to Indiana Code § 27-1-15.6-12(g), on June 14, 2021, the Commissioner issued a Suspension Order suspending Respondent’s license #3167070 until such time the Commissioner received Respondent’s list of appointments.

6. On November 11, 2021, Respondent sent an email to the Department providing a list of their appointments.

WHEREFORE, the Department respectfully requests the Commissioner issue an order lifting the suspension of Respondent's license and all other relief just and proper upon the premise.

FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Adroit Health Group, LLC (“Respondent”) is a nonresident insurance producer organization holding license number 3167070;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer organization shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request, within ten (10) days of receiving a request;

WHEREAS, on April 13, 2021, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a letter via certified mail article # 7018 1130 0001 7980 2974 requesting a list of appointments to Respondent’s address of record;

WHEREAS, on April 19, 2021, certified mail article # 7018 1130 0001 7980 2974 was successfully delivered to Respondent by the United States Postal Service;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner’s request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's nonresident insurance producer organization license number 3167070 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
