FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request, within ten (10) days of receiving a request;

WHEREAS, on April 30, 2021, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a letter via certified mail article # 7018 1130 0001 7980 3148 requesting a list of appointments to Respondent's address of record;

WHEREAS, on May 4, 2021, certified mail article # 7018 1130 0001 7980 3148 was successfully delivered to Respondent by the United States Postal Service;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days

constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may,

without a hearing and in her sole discretion, suspend any insurance license held by the licensee in

the event that the licensee fails to remit the list of appointments within ten (10) days of receiving

the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's

nonresident insurance producer license number 3284325 is hereby suspended, effective

immediately, and will remain suspended until Respondent submits the list of appointments

requested by the Commissioner.
