ADMINISTRATIVE ORDER AND
NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.*, and Indiana Code § 27-1-15.6-12, hereby gives notice to Jacquetta Colbert-Gore ("Respondent") of the following Administrative Order:


1. Respondent is a licensed nonresident insurance producer holding license number 832674 ("Respondent's license") since August 9, 2012.
2. Respondent's license expires on September 30, 2021.
3. On Respondent's 2019 renewal, Respondent failed to disclose an administrative action from March 6, 2013, from the State of Florida, wherein Respondent was denied licensure due to a felony conviction from 1990.
4. Respondent disclosed the Florida administrative action in her current renewal application.
5. Respondent to date has yet to report any of her criminal convictions to the Department, which include the following:

- a. On or around October 30, 1995, Respondent was convicted of Falsification (to obtain benefits) for workers compensation benefits, a First-Degree Misdemeanor.
 - b. On or around July 29, 1994, Respondent was convicted of Falsification (to obtain benefits) for food stamps, a First-Degree Misdemeanor.
 - c. On or around August 6, 1990, Respondent was convicted of Theft of Cash and Merchandise, a Fourth Degree Felony.
 - d. On or around October 3, 1988, Respondent was convicted of Passing Bad Checks, a First-Degree Misdemeanor.
6. Indiana Code § 27-1-28-18(b)(1) states, in part, that the Commissioner may refuse to renew an independent adjuster's license for providing incorrect, misleading, incomplete, or materially untrue information in a license application.
7. Indiana Code § 27-1-28-18(b)(6) states, in part, that the Commissioner may refuse to renew an independent adjuster's license for having been convicted of a felony.
8. Indiana Code § 27-1-28-18-(b)(2) states, in part, that the Commissioner may refuse to renew an independent adjuster's license for violating an insurance law.
9. Indiana Code § 27-1-28-22(a)(1) is an insurance law that states that an independent adjuster shall report to the Commissioner an administrative action taken against the independent adjuster, in another jurisdiction, not more than thirty (30) days after the final disposition of the matter.
10. Indiana Code § 27-1-28-18(b)(9) states, in part, that the Commissioner may refuse to renew an independent adjuster's license for having an insurance license, or its equivalent, probated, suspended, revoked, or refused in another state, province, district, or territory.

11. Indiana Code § 27-1-28-18-(c) provides that when the Commissioner refuses to renew a license, the Commissioner shall notify the Respondent, in writing, of the reasons for the nonrenewal. This Order serves as that notice.
12. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-28-18(c), Respondent may, within thirty (30) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within twenty (20) days from the date of receipt of Respondent's written demand.
13. This is considered an agency action. This action has been initiated by the aforementioned authority. If you choose to appeal this agency action, the State of Indiana Office of Administrative Law Proceedings ("OALP") will assign an administrative law judge to preside over this matter, and subsequently you will be contacted by the OALP with more information to begin the administrative process.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that **Respondent's license shall not be renewed** due to Respondent's failure to disclose her criminal activity which includes a felony conviction, and for failing to timely report an administrative action, which included a license denial.
