PRELIMINARY ADMINISTRATIVE ORDER
AND NOTICE OF LICENSE DENIAL

The Indiana Department of Insurance (“Department”), pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.* and Indiana Code § 27-1-15.6-12, hereby gives notice to Marquita Johnson (“Applicant”) of the following Administrative Order:


1. Applicant applied for an Indiana nonresident producer license on or around July 2, 2021.
2. On said application, Applicant disclosed that on or around May 8, 2020, Applicant was charged with Domestic Assault, a Third-Degree Felony, and Unlawful Use of a Weapon, a Class E Felony, in the State of Missouri.
3. Investigators attempted to contact Applicant via US mail for additional information on the aforementioned pending criminal case; as of the date of this Order Applicant has not responded to the Department’s requests.
4. On or around September 13, 2021, the Kansas Department of Insurance took administrative action against Applicant, denying Applicant’s request for licensure due to criminal history.

5. Before approving an application, the Commissioner must find that the applicant has met specific requirements under Indiana Code § 27-1-15.6-8 and Indiana Code § 27-1-15.6-12.
6. Indiana Code § 27-1-15.6-12(b)(1) states, in part, that the Commissioner may refuse to issue an insurance producer's license for providing incorrect, misleading, incomplete, or materially untrue information in a license application.
7. Indiana Code § 27-1-15.6-12(b)(9) states, in part, that the Commissioner may refuse to issue an insurance producer's license for having an insurance producer license, or its equivalent, denied, suspended, or revoked in any other state, province, district or territory.
8. Following a review of public records and the materials submitted by the Applicant, the Commissioner, being fully advised, now hereby notifies Applicant that she has not fully met the requirements of licensure, as stated by Indiana Codes §§ 27-1-15.6-12(b)(1) and 27-1-15.6-12(b)(9), due to Applicant's failure to provide complete information on her pending criminal case and due to Applicant's September 13, 2021, administrative action which involved a license denial by the State of Kansas.
9. Indiana Code § 27-1-15.6-12(d) provides that the Applicant may, not more than sixty-three (63) days after notice of denial of the applicant's application is mailed, make written demand to the Commissioner for a hearing before the Commissioner to determine the reasonableness of the Commissioner's action.
10. This is considered an agency action. This action has been initiated by the aforementioned authority. If you choose to appeal this agency action, the State of Indiana Office of Administrative Law Proceedings ("OALP") will assign an administrative law judge to preside over this matter, and subsequently you will be contacted by the OALP with more information to begin the administrative process.

IT IS THEREFORE ORDERED that Applicant's request for licensure is hereby DENIED pursuant to Indiana Codes §§ 27-1-15.6-12(b)(1) and 27-1-15.6-12(b)(9), due to Applicant's failure to provide complete information on her pending criminal case and administrative action, which involves a license denial. Applicant may reapply for licensure not less than one (1) year from the date of this order.
