PRELIMINARY ADMINISTRATIVE ORDER AND NOTICE OF LICENSE DENIAL

The Indiana Department of Insurance ("Department"), pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq*. and Indiana Code § 27-1-15.6-12, hereby gives notice to Justin Ellis ("Applicant") of the following Administrative Order:

- Applicant applied for an Indiana nonresident producer license on or around December 6,
 2021.
- 2. Applicant failed to disclose his February 17, 2020, Wisconsin Department of Insurance administrative action, a license denial due to criminal history.
- 3. Applicant failed to disclose his June 12, 2020, Indiana Department of Insurance administrative action, a license denial due to criminal history.
- 4. Applicant failed to disclose his June 24, 2021, Louisiana Department of Insurance administrative action, a license suspension due to failure to pay fine.

- 5. Before approving an application, the Commissioner must find that the applicant has met specific requirements under Indiana Code § 27-1-15.6-8 and Indiana Code § 27-1-15.6-12.
- 6. Indiana Code § 27-1-15.6-12(b)(1) states, in part, that the Commissioner may refuse to issue an insurance producer's license for providing incorrect, misleading, incomplete, or materially untrue information in a license application.
- 7. Indiana Code § 27-1-15.6-12(b)(9) states, in part, that the Commissioner may refuse to issue an insurance producer's license for having an insurance producer license, or its equivalent, denied, suspended, or revoked in any other state, province, district or territory.
- 8. Following a review of public records and the materials submitted by the Applicant, the Commissioner, being fully advised, now hereby notifies Applicant that he has not fully met the requirements of licensure, as stated by Indiana Codes §§ 27-1-15.6-12(b)(1) and 27-1-15.6-12(b)(9), due to Applicant's failure to disclose administrative actions which involved a license denials by Indiana and Wisconsin and a Louisiana Suspension.
- 9. Indiana Code § 27-1-15.6-12(d) provides that the Applicant may, not more than sixty-three (63) days after notice of denial of the applicant's application is mailed, make written demand to the Commissioner for a hearing before the Commissioner to determine the reasonableness of the Commissioner's action.
- 10. This is considered an agency action. This action has been initiated by the aforementioned authority. If you choose to appeal this agency action, the State of Indiana Office of Administrative Law Proceedings ("OALP") will assign an administrative law judge to preside over this matter, and subsequently you will be contacted by the OALP with more information to begin the administrative process.

IT IS THEREFORE ORDERED that Applicant's request for licensure is hereby DENIED pursuant to Indiana Codes §§ 27-1-15.6-12(b)(1) and 27-1-15.6-12(b)(9), due to Applicant's failure to disclose three administrative actions, which include a license denial from another state. Applicant may reapply for licensure not less than one (1) year from the date of this order.
