ADMINISTRATIVE ORDER AND NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 et seq., and Indiana Code § 27-1-15.6-12, hereby gives notice to Kyle Wittgren, ("Respondent") of the following Administrative Order:

- 1. Respondent is a licensed resident insurance producer holding license number 3151666 since April 12, 2016, ("Respondent's license").
 - 2. Respondent's license expired on April 30, 2022.
- 3. On December 27, 2021, Respondent entered into an Acceptance, Waiver and Consent (AWC) agreement wherein Respondent is barred from acting as a broker and from associating with any FINRA member in all capacities.
- 4. Respondent failed to timely report the FINRA administrative action to the Department.

- 5. On January 28, 2022, the Minnesota Department of Insurance issued a Consent Order revoking Respondent's license.
- 6. Respondent failed to timely report his Minnesota administrative action to the Department.
- 7. On February 15, 2022, Respondent's license was revoked for forgery in the State of Illinois.
- 8. Respondent failed to timely report his Illinois administrative action to the Department.
- 9. Indiana Code § 27-1-15.6-12(b)(2)(A) provides, in part, that the Commissioner may refuse to renew an insurance producer's license for violating an insurance law.
- 10. Indiana Code § 27-1-15.6-17(a), provides, in part, that a producer shall report to the Commissioner any administrative action taken against the producer in another jurisdiction or by another governmental agency in Indiana not more than thirty (30) days after the final disposition.
- 11. Indiana Code § 27-1-15.6-12(b)(9), authorizes the Commissioner to refuse to renew an insurance producer's license for having an insurance producer's license or its equivalent, denied, suspended, or revoked in any other state, province, district, or territory.
- 12. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of his license. This Order serves as that notice.
- 13. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this

action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's

written demand.

This is considered an administrative action by the Indiana Department of Insurance. 14.

If you choose to appeal this administrative action, please follow the aforementioned

instructions. Subsequently, after the Department has received your written request for a hearing,

the State of Indiana Office of Administrative Law Proceedings ("OALP") will assign an

administrative law judge to preside over this matter, and you will receive more information from

OALP to begin the administrative process.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies

Respondent that his license shall not be renewed due to Respondent failing to timely report to

the Department three (3) administrative actions, which includes a FINRA action and two license

revocations.
