**MOTION TO LIFT SUSPENSION**

The Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Victoria Hastings, now moves that the Suspension Order issued on March 21, 2022, in this matter be lifted. In support of this request, the Department asserts the following:

1. Jida Sherita Robertson (“Respondent”) is a nonresident insurance producer holding license #3568482 since august 17, 2020;
2. On February 28, 2022, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a certified letter requesting a list of appointments;
3. More than ten (10) days elapsed since the Commissioner requested a list of appointments without a response from Respondent;
4. Pursuant to Indiana Code § 27-1-15.6-12(g), on March 21, 2022, the Commissioner issued a Suspension Order suspending Respondent’s license #3568482 until such time as the Commissioner received Respondent’s list of appointments;
5. On April 1, 2022, Respondent sent an email to the Department providing a list of their appointments.

WHEREFORE, the Department respectfully requests that the Commissioner issue an order lifting the suspension of Respondent's license, and for all other relief just and proper in the premises.

**FINDINGS OF FACT AND SUSPENSION ORDER**

WHEREAS, Jida Sherita Robertson (“Respondent”) is a nonresident insurance producer holding license number 3568482 since August 17, 2020;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on February 28, 2022, the Commissioner mailed Respondent a certified mail article # 7016 2070 0001 1480 0841 requesting a list of appointments to Respondent’s address of record;

WHEREAS, on March 5, 2022, certified mail article # 7016 2070 0001 1480 0841 was signed for by Respondent at Respondent’s address of record;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner’s request;


WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

**IT IS THEREFORE ORDERED BY THE COMMISSIONER** that Respondent's license number 3568482 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
