FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, David E. Laffin and Digital Ins. Solutions, LLC (“Respondents”) are a resident insurance producer holding license number 792745, and a resident producer organization holding license number 3333755, respectively;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request, within ten (10) days of receiving a request;

WHEREAS, on March 10, 2022, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondents a letter via certified mail article # 7018 1130 0001 7980 3018 requesting a list of appointments to Respondents’ address of record;

WHEREAS, on March 23, 2022, certified mail article # 7018 1130 0001 7980 3018 was returned to the Department by the United States Postal Service marked “return to sender”;

WHEREAS, on March 24, 2022, the Commissioner also sent request for a list of appointments to Respondents via email to the email addresses on record for Respondents;


WHEREAS, Respondents have failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondents' failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondents' resident insurance producer license number 792945 and resident producer organization license number 3333755 is hereby suspended, effective immediately, and will remain suspended until Respondents submit the list of appointments requested by the Commissioner.
