**MOTION TO LIFT SUSPENSION**

The Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Samantha Aldridge, now moves that the Suspension Order issued on June 1, 2022, in this matter be lifted. In support of this request, the Department asserts the following:

1. Devin Rose ("Respondent") is a nonresident insurance producer under license number 3686107;
2. On March 11, 2022, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a certified letter requesting a list of appointments;
3. More than ten (10) days elapsed since the Commissioner requested a list of appointments without a response from Respondent;
4. Pursuant to Indiana Code § 27-1-15.6-12(g), on June 1, 2022, the Commissioner issued a Suspension Order suspending Respondent's license #3686107 until such time as the Commissioner received Respondent's list of appointments;
5. On July 10, 2022, Respondent sent an email to the Department providing a list of his appointments.

WHEREFORE, the Department respectfully requests that the Commissioner issue an order lifting the suspension of Respondent's license, and for all other relief just and proper in the premises.

**FINDINGS OF FACT AND SUSPENSION ORDER**

WHEREAS, Devin Rose ("Respondent") is a nonresident insurance producer holding license #3686107 since June 24, 2021;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner of the Indiana Department of Insurance ("Commissioner") with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on March 11, 2022, the Commissioner mailed Respondent a letter requesting a list of appointments via USPS First Class Mail to Respondent's address of record;

WHEREAS, this letter was not returned to the Commissioner as "undeliverable" or otherwise;

WHEREAS, on May 11, 2022, the Commissioner mailed Respondent a certified mail article # 7021 0350 0001 6944 9874 requesting a list of appointments to Respondent's address of record;

WHEREAS, on May 27, 2022, certified mail article # 7021 0350 0001 6944 9874 was returned to the Department which was marked as "unable to forward";

WHEREAS, Indiana Code § 27-1-15.6-12(b)(17) provides that the Commissioner may suspend an insurance producer's license for failing to timely inform the Commissioner of a change in address in violation of Indiana Code § 27-1-15.6-7(h);

WHEREAS, Respondent has failed to provide a change of address to the Commissioner within thirty (30) days after the change;


WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days and failure to provide a change of address within thirty (30) days after the change constitutes a violation of Indiana Codes §§ 27-1-15.6-12(g) and 27-1-15.6-12(b)(17); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

**IT IS THEREFORE ORDERED BY THE COMMISSIONER** that Respondent's license #3686107 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
