WHEREAS, on March 22, 2022, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a letter via certified mail article # 7021 0350 0001 8549 1215 requesting a list of companies he has held appointments with in the past twelve (12) months to Respondent's address of record;

WHEREAS, on March 25, 2022, a notice of certified mail article # 7021 0350 0001 8549

1215 was successfully delivered by the United States Postal Service to Respondent at his address of record;

WHEREAS, Respondent has failed to provide a response within ten (10) days of receiving

the Commissioner's request;

WHEREAS, Respondent's failure to provide a response within ten (10) days constitutes a

violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may,

without a hearing and in her sole discretion, suspend any insurance license held by the licensee in

the event that the licensee fails to remit the list of appointments within ten (10) days of receiving

the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's

license number 33685275 is hereby suspended, effective immediately, and will remain suspended

until Respondent submits the list of appointments requested by the Commissioner.
