**FINDINGS OF FACT AND SUSPENSION ORDER**

WHEREAS, Gage Vincent Corson (“Respondent”) is a nonresident insurance producer holding license number 3674583 since May 26, 2021;

WHEREAS, Indiana Code § 27-1-15.6-8(f) states, in part, that a licensed nonresident producer who receives a nonresident producer license shall maintain licensure in good standing in the nonresident producer’s home state;

WHEREAS, Indiana Code § 27-1-15.6-8(b) states that the Commissioner of the Indiana Department of Insurance (“Commissioner”) may verify a producer’s licensing status through the Producer Database maintained by the National Association of Insurance Commissioners (“NAIC”) and its affiliates or subsidiaries;


WHEREAS, on or about April 21, 2022, the Commissioner verified through the Producer Database maintained by the NAIC that Respondent’s producer license in his home state of Florida was no longer active as of April 15, 2022 and is no longer in effect as required under Indiana Code § 27-1-15.6-8(f);

WHEREAS, specifically, on or about April 15, 2022, Respondent's home state license in Florida was suspended due to Respondent making and submitting a fraudulent representation on an application without consent or true signature of the insured;

WHEREAS, Indiana Code § 27-1-15.6-8(g) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any Indiana insurance producer license held by the nonresident producer until the Commissioner receives notice from the nonresident producer's home state that the home state license is in effect.

**IT IS THEREFORE ORDERED BY THE COMMISSIONER** that Respondent's license number 3674583 is hereby suspended, effective immediately, and will remain suspended until the Commissioner receives notice from Respondent's home state that his home state license is in effect.
