ADMINISTRATIVE ORDER AND NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.*, and Indiana Code § 27-1-15.6-12, hereby gives notice to John B. Larkin ("Respondent") of the following Administrative Order:

- 1. Respondent is a licensed resident insurance producer holding license number 414231 since December 31 2001 ("Respondent's license").
 - 2. Respondent's license expires on June 30, 2022.
- 3. On or about September 13, 2019, Respondent was convicted of Involuntary Manslaughter, a Class C Felony.
- 4. Indiana Code § 27-1-15.6-12(b)(6) provides, in part, that the Commissioner may refuse to renew an insurance producer's license for having been convicted of a felony.
- 5. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of his license. This Order serves as that notice.

The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-6.

1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a

written demand upon the Commissioner for a hearing to determine the reasonableness of this

action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's

written demand.

This is considered an administrative action by the Indiana Department of Insurance. 7.

If you choose to appeal this administrative action, please follow the aforementioned

instructions. Subsequently, after the Department has received your written request for a hearing,

the State of Indiana Office of Administrative Law Proceedings ("OALP") will assign an

administrative law judge to preside over this matter, and you will receive more information from

OALP to begin the administrative process.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies

Respondent that his license shall not be renewed due to his felony conviction.
