FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Mark W. Just ("Respondent") is a resident insurance producer holding license number 1469820;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request, within ten (10) days of receiving a request;

WHEREAS, on June 14, 2022, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a letter via certified mail article # 7018 1130 0001 7980 3070 requesting a list of appointments to Respondent's address of record;

WHEREAS, on June 23, 2022, certified mail article # 7018 1130 0001 7980 3070 was returned by the United States Postal Service, marked "return to sender";

WHEREAS, on July 8, 2022, the Commissioner also sent request for a list of appointments to Respondent via email to the email address on record for Respondent;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days

of receiving the Commissioner's requests;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days

constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may,

without a hearing and in her sole discretion, suspend any insurance license held by the licensee in

the event that the licensee fails to remit the list of appointments within ten (10) days of receiving

the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's

resident insurance producer license number 1469820 is hereby suspended, effective immediately,

and will remain suspended until Respondent submits the list of appointments requested by the

Commissioner.
