

MOTION TO LIFT SUSPENSION

The Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Samantha Aldridge, now moves that the Suspension Order issued on May 31, 2022, in this matter be lifted. In support of this request, the Department asserts the following:

1. Donald Tidwell (“Respondent”) is a nonresident insurance producer under license number 3706124;
2. On April 12, 2022, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a certified letter requesting a list of appointments;
3. More than ten (10) days elapsed since the Commissioner requested a list of appointments without a response from Respondent;
4. Pursuant to Indiana Code § 27-1-15.6-12(g), on May 31, 2022, the Commissioner issued a Suspension Order suspending Respondent’s license #3706124 until such time as the Commissioner received Respondent’s list of appointments;
5. On July 26, 2022, Respondent sent an email to the Department providing a list of his appointments.

WHEREFORE, the Department respectfully requests that the Commissioner issue an order lifting the suspension of Respondent's license, and for all other relief just and proper in the premises.

FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Donald Tidwell (“Respondent”) is a nonresident insurance producer holding license #3706124 since August 9, 2021;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on April 12, 2022, the Commissioner mailed Respondent a letter via certified mail article # 7021 0350 0001 6944 1281 requesting a list of appointments to Respondent’s address of record;

WHEREAS, on April 16, 2022, certified mail article # 7021 0350 0001 6944 1281 was marked as “delivered” to Respondent at Respondent’s address of record;


WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner’s request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license #3706124 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
