MOTION TO LIFT SUSPENSION

The Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Samantha Aldridge, now moves that the Suspension Order issued on August 3, 2022, in this matter be lifted. In support of this request, the Department asserts the following:

1. Gregory Town (“Respondent”) is a nonresident insurance producer under license number 590196;
2. On April 27, 2022, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a certified letter requesting a list of appointments;
3. More than ten (10) days elapsed since the Commissioner requested a list of appointments without a response from Respondent;
4. Pursuant to Indiana Code § 27-1-15.6-12(g), on August 3, 2022, the Commissioner issued a Suspension Order suspending Respondent’s license #590196 until such time as the Commissioner received Respondent’s list of appointments; -
5. On August 10, 2022, Respondent sent an email to the Department providing a list of his appointments.

WHEREFORE, the Department respectfully requests that the Commissioner issue an order lifting the suspension of Respondent's license, and for all other relief just and proper in the premises.

FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Gregory Town ("Respondent") is a nonresident insurance producer holding license number 590196;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request, within ten (10) days of receiving a request;

WHEREAS, on April 27, 2022, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a letter via certified mail article # 7021 0350 0001 6947 5019 requesting a list of companies he has held appointments with in the past twelve (12) months to Respondent's address of record;

WHEREAS, on July, 21, 2022, a notice of certified mail article # 7021 0350 0001 6947 5019 was successfully delivered by the United States Postal Service;

WHEREAS, Respondent has failed to provide a response within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide a response within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 590196 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
