PRELIMINARY ADMINISTRATIVE ORDER
AND NOTICE OF LICENSE DENIAL

The Indiana Department of Insurance, pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.* and Indiana Code § 27-1-15.6-12, hereby gives notice to Brian Lalusin (“Applicant”) of the following Administrative Order:

1. Applicant was previously licensed as a nonresident producer with the Indiana Department of Insurance from October 14, 2011, to December 29, 2016, under license number 3769231.
2. Applicant filed an application to reactivate his nonresident producer licensure with the Commissioner of the Indiana Department of Insurance (“Commissioner”) on April 6, 2022.
3. Before approving an application, the Commissioner must find that the applicant has met specific requirements under Indiana Code § 27-1-15.6-8 and Indiana Code § 27-1-15.6-12.
4. Indiana Code § 27-1-15.6-12(b)(9) provides, in part, that the Commissioner may refuse to issue an insurance producer’s license for having an insurance producer’s license or its equivalent, denied, suspended, or revoked in any other state, province, district or territory.

5. Indiana Code § 27-1-15.6-12(b)(2)(A), provides, in part, that the Commissioner may refuse to issue an insurance producer's license for violating an insurance law.
6. Indiana Code § 27-1-15.6-17(a), is an insurance law that states that a producer shall report to the Commissioner any administrative action taken against the producer in another jurisdiction or by another governmental agency in Indiana not more than thirty (30) days after the final disposition of the matter.
7. Following a review of public records and a review of materials submitted by Applicant in support of his application, the Commissioner, being fully advised, now hereby notifies Applicant that he has not fully met the requirements of licensure as stated by Indiana Code § 27-1-15.6-12(b)(9), due to the following administrative actions:
 - a. May 9, 2013 license revocation by the Virginia Bureau of Insurance;
 - b. September 25, 2015 license revocation by the Delaware Department of Insurance;
 - c. April 26, 2016 license revocation by the Virginia Bureau of Insurance; and
 - d. May 10, 2016 license denial by the Oregon Division of Financial Regulation.
8. Following a review of public records and a review of materials submitted by Applicant in support of his application, the Commissioner, being fully advised, now hereby notifies Applicant that he has not fully met the requirements of licensure as stated by Indiana Codes §§ 27-1-15.6-12(b)(2)(A) and 27-1-15.6-17(a), due to his failure to timely report the following administrative actions to the Department during his previous period of licensure:
 - a. May 9, 2013 license revocation by the Virginia Bureau of Insurance;
 - b. April 26, 2016 license revocation by the Virginia Bureau of Insurance;

- c. May 10, 2016 license denial by the Oregon Division of Financial Regulation;
and
 - d. October 31, 2016 monetary penalty by the Louisiana Department of Insurance.
8. Indiana Code § 27-1-15.6-12(d) provides that the applicant may, not more than sixty-three (63) days after notice of denial of the application is mailed, make written demand to the Commissioner for a hearing before the Commissioner to determine the reasonableness of the Commissioner's action.
9. This is considered an administrative action by the Indiana Department of Insurance. If you choose to appeal this administrative action, please follow the aforementioned instructions. Subsequently, after the Department has received your written request for a hearing, the State of Indiana Office of Administrative Law Proceedings ("OALP") will assign an administrative law judge to preside over this matter, and you will receive more information from OALP to begin the administrative process.

IT IS THEREFORE ORDERED that Applicant's request for licensure is hereby **DENIED** pursuant to Indiana Codes §§ 27-1-15.6-12(b)(9) and 27-1-15.6-12(b)(2)(A) due to Applicant's three (3) license revocations, one (1) license denial, and his failure to timely report four (4) of his administrative actions to the Department. Applicant may reapply for licensure not less than one (1) year from the date of this order.
