WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request, within ten (10) days of receiving a request;

WHEREAS, on July 10, 2022, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a letter via certified mail article # 7017 2620 0000 5734 1850 requesting a list of companies he has held appointments with in the past twelve (12) months to Respondent's address of record;

WHEREAS, on July 14, 2022, a notice of certified mail article 7017 2620 0000 5734 1850 was successfully delivered by the United States Postal Service;

WHEREAS, Respondent has failed to provide a response within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide a response within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 3770315 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
