The Indiana Department of Insurance Enforcement Division ("Department"), by counsel, Victoria Hastings, now moves for the Suspension Order of November 7, 2022 be lifted. In support of this request the Department asserts the following:


1. First United Bank Insurance solutions, Inc. ("Respondent") is a nonresident insurance producer organization under license #35027544.
2. On September 9, 2022 the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a letter via certified mail article #7021 0350 0001 6947 5187 requesting a list of appointments.
3. On September 13, 2022, certified mail article # 7021 0350 0001 6947 5187 was successfully delivered by the United States Postal Service.
4. More than ten (10) days elapsed since the Commissioner requested a list of appointments without a response from Respondent.
5. Pursuant to Indiana Code § 27-1-15.6-12(g), on November 7, 2022, the Commissioner issued a Suspension Order suspending Respondent's license

#35027544 until such time the Commissioner received Respondent's list of appointments.

6. On December 9, 2022, the Department received Respondent's list of appointments via FedEx Mailer.

WHEREFORE, the Department respectfully requests the Commissioner issue an order lifting the suspension of Respondent's license and all other relief just and proper upon the premise.
