MOTION TO LIFT SUSPENSION ORDER

The Indiana Department of Insurance Enforcement Division (“Department”), by counsel, Samantha Aldridge, now moves for the Suspension Order of Seguro Medico, LLC be lifted. In support of this request the Department asserts the following:

1. Seguro Medico, LLC (“Respondent”) is a nonresident insurance producer organization under license #3523064.
2. On January 24, 2023 the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a letter via certified mail article #7021 0350 0001 6947 7648 requesting a list of appointments.
3. On January 30, 2023, certified mail article #7021 0350 0001 6947 7648 was successfully delivered by the United States Postal Service.
4. More than ten (10) days elapsed since the Commissioner requested a list of appointments without a response from Respondent.
5. Pursuant to Indiana Code § 27-1-15.6-12(g), on February 14, 2023, the Commissioner issued a Suspension Order suspending Respondent’s license

#3523064 until such time the Commissioner received Respondent's list of appointments.

6. On March 1, 2023, the Department received Respondent's list of appointments via email.

WHEREFORE, the Department respectfully requests the Commissioner issue an order lifting the suspension of Respondent's license and all other relief just and proper upon the premise.

FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Seguro Medico, LLC (“Respondent”) is a nonresident insurance producer organization holding license 3364172 since February 19, 2020;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on January 24, 2023, the Commissioner mailed Respondent a certified mail article # 7021 0350 0001 6947 7648 requesting a list of appointments to Respondent’s address of record;

WHEREAS, the certified mail tracking system confirms certified mail article 7021 0350 0001 6947 was “delivered, left with individual” on January 30, 2023;


WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner’s request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license #3523064 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
