**FINDINGS OF FACT AND SUSPENSION ORDER**

WHEREAS, Yuki Hamanaka (“Respondent”) is a nonresident independent adjuster holding license number 3335641;

WHEREAS, Indiana Code § 27-1-28-17(d)(1) states, in part, that a nonresident independent adjuster who receives a nonresident independent adjuster license shall maintain valid licensure in good standing in the nonresident independent adjuster’s home state;

WHEREAS, Indiana Code § 27-1-28-17(c)(1) states, in part, that the Commissioner of the Indiana Department of Insurance (“Commissioner”) may verify an independent adjuster’s licensure status through the insurance producer data base maintained by the National Association of Insurance Commissioners (“NAIC”) and its affiliates or subsidiaries;

WHEREAS, on January 20, 2023, the Commissioner verified through the Producer Database maintained by the NAIC that Respondent does not have a home state license required under Indiana Code § 27-1-28-17(d)(1); and

WHEREAS, Indiana Code 27-1-28-17(f)(1) states, in part, that if a nonresident independent adjuster’s home state license terminates for any reason other than the issuance of a


new resident independent adjuster license in a new home state, the person's nonresident independent adjuster license also terminates immediately.

WHEREAS, Indiana Code 27-1-28-17(f)(2) states, in part, if a nonresident independent adjuster's home state license terminates for any reason other than the issuance of a new resident independent adjuster license in a new home state, then the person shall immediately surrender their nonresident independent adjuster's license to the Commissioner.

**IT IS THEREFORE ORDERED BY THE COMMISSIONER** that Respondent's license number 3335641 is hereby suspended, effective immediately, and Respondent shall immediately surrender her license number 3335641 to the Commissioner.
