## PRELIMINARY ADMINISTRATIVE ORDER AND NOTICE OF LICENSE DENIAL

The Indiana Department of Insurance, pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.* and Indiana Code § 27-1-15.6-12, hereby gives notice to Vetinsure, LLC ("Respondent") of the following Administrative Order:

- 1. Respondent previously held an Indiana nonresident producer organization licensure, under license number 3302586, from January 3, 2018 through October 29, 2020.
- 2. On or about August 21, 2020 the Department issued a Nonrenewal Order due to Respondent's disclosure of unreported other state administrative actions on an application.
- 3. On or about November 10, 2022 Respondent submitted an application for nonresident producer organization licensure with the Commissioner of the Indiana Department of Insurance ("Commissioner").
- 4. Before approving an application, the Commissioner must find that the Respondent has met specific requirements under Indiana Code § 27-1-15.6-8 and Indiana Code § 27-1-15.6-12.

5. On the November 10, 2022 application, Respondent disclosed an August 29, 2012 license denial from the State of Wisconsin for failure to respond to written request for information related to Respondent's Wisconsin application for licensure.

6. Indiana Code § 27-1-15.6-12(b)(9) provides, in part, that the Commissioner may refuse to issue or renew an insurance producer license for having an insurance producer license, or its equivalent, denied, suspended, or revoked in any other state, province, district, or territory.

7. Following a review of public records, the Commissioner being fully advised, now hereby notifies Respondent that Respondent has not fully met the requirements of licensure as stated by Indiana Code § 27-1-15.6-12(b)(9) due to Respondent's license denial from the State Wisconsin on August 29, 2012.

8. Indiana Code § 27-1-15.6-12(d) provides that the Respondent may, not more than sixty-three (63) days after notice of denial of the application is mailed, make written demand to the Commissioner for a hearing before the Commissioner to determine the reasonableness of the Commissioner's action.

IT IS THEREFORE ORDERED that Respondent's request for licensure is hereby DENIED pursuant to Indiana Code § 27-1-15.6-12(b)(9) for having an insurance producer licensure denied by another state. Respondent may reapply for licensure not less than one (1) year from the date of this order.
