- Lamont Liggins (Respondent") is a licensed resident insurance producer holding license number 791890.
- 2. On or about June 22, 2023, the Department received notice from the Indiana Department of Child Services Child Support Bureau (the "Bureau"), that Respondent is responsible for child support arrearage in the amount of \$8,696.77 under Indiana Child Support Case Number 3067059.
- 3. On July 25, 2023, the Commissioner entered a Findings of Fact and Probation Order pursuant to Indiana Code § 27-1-15.6-29, placing Respondent's producer license on probationary status.
- 4. On August 11, 2023, the Department received notice from the Bureau that Respondent resolved the child support delinquency by establishing a payment plan

including an income withholding order as required by Indiana Code § 27-1-15.6-29.

5. Pursuant to Indiana Code § 27-1-15.6-29(c), the Commissioner may now reinstate Respondent's license as Respondent is now in compliance.
