PRELIMINARY ADMINISTRATIVE ORDER AND NOTICE OF LICENSE DENIAL

The Indiana Department of Insurance, pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.* and Indiana Code § 27-1-15.6-12, hereby gives notice to Danyel R. Fladhammer ("Applicant") of the following Administrative Order:

- Applicant previously held an Indiana nonresident producer license originally issued on July
 20, 2009. On November 24, 2015, the Indiana Department of Insurance suspended
 Applicants' license for failure to report other states' actions.
- 2. Applicant filed an application for nonresident producer licensure with the Commissioner of the Indiana Department of Insurance ("Commissioner") on July 6, 2023.
- 3. Before approving an application, the Commissioner must find that the applicant has met specific requirements under Indiana Code § 27-1-15.6-8 and Indiana Code § 27-1-15.6-12.
- 4. Indiana Code § 27-1-15.6-12(b)(1) provides, in part, that the Commissioner may refuse to issue an insurance producer license for providing incorrect, misleading, incomplete, or materially untrue information in a license application.

- 5. Indiana Code § 27-1-15.6-12(b)(9) provides, in part, that the Commissioner may refuse to issue an insurance producer license for having an insurance producer license, or its equivalent, denied, suspended, or revoked in any other state, province, district, or territory.
- 6. Following a review of public records and materials, the Commissioner, being fully advised, now hereby notifies Applicant that Applicant has not fully met the requirements of licensure, as stated by Indiana Codes §§ 27-1-15.6-12(b)(1) and 27-1-15.6-12(b)(9) for failing to disclose the following four (4) administrative actions on the July 6, 2023 application, including two (2) license revocations:
 - a. On August 28, 2015, the North Dakota Insurance Department revoked Applicant's license for failure to respond to the department's inquiry, to notify the department of a change of address, and to report an April 7, 2014 criminal conviction.
 - b. On November 24, 2015, the Indiana Department of Insurance suspended Applicant's license for failure to report other states' actions.
 - c. On November 4, 2016, the Wisconsin Office of the Commissioner of Insurance levied a monetary penalty against Applicant's license for failure to report other state actions and for providing incorrect information on an application for license reinstatement.
 - d. On April 12, 2017, the Ohio Department of Insurance revoked Applicant's license for having a license denied by another jurisdiction.
- 7. Indiana Code § 27-1-15.6-12(d) provides that the applicant may, not more than sixty-three (63) days after notice of denial of the application is mailed, make written demand to the Commissioner for a hearing before the Commissioner to determine the reasonableness of the Commissioner's action.

8. This is considered an administrative action by the Indiana Department of Insurance. If you choose to appeal this administrative action, please follow the aforementioned instructions. Subsequently, after the Department has received your written request for a hearing, the State of Indiana Office of Administrative Law Proceedings ("OALP") will assign an administrative law judge to preside over this matter, and you will receive more information from OALP to begin the administrative process.

IT IS THEREFORE ORDERED that Applicant's request for licensure is hereby **DENIED** pursuant to Indiana Codes §§ 27-1-15.6-12(b)(1) and 27-1-15.6-12(b)(9) due to Applicant's failure to disclose four (4) administrative actions including two (2) actions that involved a license revocation. Applicant may reapply for licensure not less than one (1) year from the date of this order.
