**ADMINISTRATIVE ORDER AND**  
**NOTICE OF NONRENEWAL OF LICENSE**

The Indiana Department of Insurance (“Department”), pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.*, and Indiana Code § 27-1-15.6-12, hereby gives notice to Andre Berry (“Respondent”) of the following Administrative Order:

1. Respondent is a licensed nonresident insurance producer holding license number 3590479 (“Respondent’s license”) since October 7, 2020.
2. Respondent’s license expired on June 30, 2023.
3. On May 3, 2022, the Connecticut Department of Insurance revoked Respondent’s nonresident producer’s license for failure to remit monies owed for Respondent’s individual Connecticut Insurance license renewal.
4. Respondent did not timely notify this Department of the administrative actions taken against Respondent’s license by the Connecticut Department of Insurance reporting the action to the Department on February 7, 2023.

5. On September 29, 2022 the South Dakota Department of Labor and Regulation Division of Insurance revoked the Respondent's nonresident producer's license for failure to respond timely to the Division's inquiries and for having a license revocation or suspension in another state.
6. Respondent did not timely notify this Department of the administrative actions taken against Respondent's license by the South Dakota Department of Labor and Regulation, Division of Insurance, reporting the action to the Department on February 7, 2023.
7. Indiana Code § 27-1-15.6-12(b)(2)(A) states, in part, that the Commissioner may refuse to renew an insurance producer license for violating an insurance law.
8. Indiana Code § 27-1-15.6-17(a) is an insurance law that states that not more than thirty days after the final disposition of the matter, a producer shall report to the Commissioner any administrative action taken against the producer initiated in any jurisdiction or governmental agency.
9. Indiana Code § 27-1-15.6-12(b)(9) states, in part, that the Commissioner may refuse to renew an insurance producer license for having an insurance producer license, or its equivalent, denied, suspended, or revoked in any other state, province, district, or territory.
10. Indiana Code § 27-1-15.6-12(d) provides that when the Commissioner refuses to renew a license, the Commissioner shall notify the Respondent, in writing, of the reasons for the nonrenewal. This Order serves as that notice.
11. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the

reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

12. This is considered an agency action. This action has been initiated by the aforementioned authority. If you choose to appeal this agency action, the State of Indiana Office of Administrative Law Proceedings ("OALP") will assign an administrative law judge to preside over this matter, and subsequently you will be contacted by the OALP with more information to begin the administrative process.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that **Respondent's license shall not be renewed** due to failure to timely report two (2) administrative actions taken against the Respondent's license in other jurisdictions, and for having had an insurance producer's license revoked in another jurisdiction.
