MOTION TO LIFT SUSPENSION

The Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Samantha Aldridge, now moves that the Suspension Order issued on June 29, 2023, in this matter be lifted. In support of this request, the Department asserts the following:

1. De Shawn Joyner (“Respondent”) is a nonresident insurance producer holding license #3871372 since February 2, 2023;
2. On June 12, 2023, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a certified letter requesting a list of appointments;
3. More than ten (10) days elapsed since the Commissioner requested a list of appointments without a response from Respondent;
4. Pursuant to Indiana Code § 27-1-15.6-12(g), on June 29, 2023, the Commissioner issued a Suspension Order suspending Respondent’s license #3871372 until such time as the Commissioner received Respondent’s list of appointments;
5. On July 31, 2023, Respondent sent an email to the Department providing a list of Respondent’s appointments.

WHEREFORE, the Department respectfully requests that the Commissioner issue an order lifting the suspension of Respondent's license, and for all other relief just and proper in the premises.
