WHEREAS, pursuant to Indiana Code § 27-1-15.6-29, upon receiving an order from the Bureau under Indiana Code § 31-25-4-32(i) or Indiana Code § 31-25-4-34(d), the Commissioner shall place Respondent's producer license into probationary status;

WHEREAS, pursuant to Indiana Code § 27-1-15.6-29, the Commissioner shall send Respondent a notice that Respondent's license has been placed into probationary status;

WHEREAS, this Order serves as that notice;

WHEREAS, Respondent shall either pay the child support arrearage in full, or establish a

payment plan with the Bureau to pay the arrearage, which payment plan must include an income

Code § 31-25-4-32(m) or Indiana Code § 31-25-4-34(g) that Respondent has addressed the

delinquency within twenty (20) days after the date of this notice, the Commissioner shall

suspend Respondent's license; and

WHEREAS, the Commissioner may not reinstate a suspended license earlier than ten

(10) business days after the Commissioner receives notice from the Bureau that Respondent has

addressed the delinquency under Indiana Code § 31-25-4-32(m) or Indiana Code § 31-25-4-

34(g).

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license

number 3460951 is hereby placed on probationary status, effective immediately.
