## ADMINISTRATIVE ORDER NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 et seq., and Indiana Code § 27-1-15.6-12, hereby gives notice to Alexandria Bowman ("Respondent") of the following Administrative Order:

- 1. Respondent is a licensed nonresident insurance producer holding license number 3604843 ("Respondent's license") since November 5, 2020.
- 2. Respondent's license expired on April 30, 2023.
- 3. On or about April 30, 2023, Respondent submitted a renewal application.
- 4. On or about January 31, 2023, Respondent was involved in an administrative action from the Wisconsin Department of Insurance, wherein her license was surrendered due to misrepresenting an insurance product/policy.
- 5. Respondent failed to disclose this administrative action on her renewal application.

- 6. Respondent failed to timely report this administrative action to the Department within 30 days.
- 7. Indiana Code § 27-1-15.6-12(b)(1) states, in part, that the Commissioner may refuse to renew an insurance producer license for providing incorrect, misleading, incomplete, or materially untrue information in a license application.
- 8. Indiana Code § 27-1-15.6-12(b)(2)(A) states, in part, that the Commissioner may refuse to renew an insurance producer license for violating and insurance law.
- 9. Indiana Code § 27-1-15.6-17(a) is an insurance law which states, in part, that a producer shall report to the Commissioner any administrative action taken against the producer not more than thirty (30) days after the final disposition of the matter.
- 10. Following a review of public records and the materials, the Commissioner, being fully advised, now hereby notifies Respondent that she has not fully met the requirements of licensure, as stated by Indiana Codes §§ 27-1-15.6-12(b)(1), 27-1-15.6-12(b)(2)(A) and 27-1-15.6-17(a), due to Respondent failing to timely report an administrative action to the Department, and for failing to disclose the same administrative action to the Department on Respondent's renewal application.
- 11. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.
- 12. This is considered an agency action. This action has been initiated by the aforementioned authority. If you choose to appeal this agency action, the State of Indiana Office of

Administrative Law Proceedings ("OALP") will assign an administrative law judge to preside over this matter, and subsequently you will be contacted by the OALP with more information to begin the administrative process.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that Respondent's license shall not be renewed due to failing to disclose an administrative action on her renewal application and for failing to timely report the same.
