FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Brandie Byrd ("Respondent") is a nonresident insurance producer holding license number 508783 since June 16, 2020;

WHEREAS, Respondent's nonresident producer license expires March 21, 2025;

WHEREAS, Respondent previously held nonresident producer license number 508783 from October 23, 2006 to October 31, 2010 when Respondent failed to renew;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on May 25, 2023, the Commissioner mailed Respondent a certified mail article # 7021 0350 0001 6947 7815 requesting a list of appointments to Respondent's address of record;

WHEREAS, on June 5, 2023 certified mail article # 7021 0350 0001 6947 7815 was returned to the Department marked as "Returned to Sender, Attempted- Not Known, Unable to Forward.";

WHERERAS, on September 11, 2023 the Department communicated with Respondent by phone wherein Respondent confirmed the accuracy of his address of record and email;

WHEREAS, on September 11, 2023 a request for a list of appointments was sent via email to Respondent;

WHERERAS, Respondent has not replied to the September 11, 2023 email as of the date of filing;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
