**PRELIMINARY ADMINISTRATIVE ORDER**  
**AND NOTICE OF LICENSE DENIAL**

The Indiana Department of Insurance (“Department”), pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.* and Indiana Code § 27-1-15.6-12, hereby gives notice to Marquita Johnson (“Applicant”) of the following Administrative Order:

1. Applicant submitted an application for a nonresident producer licensure with the Commissioner of the Indiana Department of Insurance (“Commissioner”) on July 18, 2023.
2. Before approving an application, the Commissioner must find that the applicant has met specific requirements under and Indiana Code § 27-1-15.6-8 and Indiana Code § 27-1-15.6-12.
3. Indiana Code § 27-1-15.6-12(b)(1) states, in part, that the Commissioner may refuse to issue an insurance producer license for providing incorrect, misleading, incomplete, or materially untrue information in a license application.


4. Indiana Code § 27-1-15.6-12(b)(9) states, in part, that the Commissioner may refuse to issue an insurance producer's license for having an insurance producer license, or its equivalent, denied, suspended, or revoked in any other state, province, district or territory.
5. Following a review of public records and the materials submitted by the Applicant, the Commissioner, being fully advised, now hereby notifies Applicant that they have not fully met the requirements of licensure, as stated by Indiana Codes §§ 27-1-15.6-12(b)(1) and 27-1-15.6-12(b)(9) due to Applicant's failure to disclose the following administrative actions on her application for licensure:
  - a. An August 25, 2021, license denial from the State of Kansas, due to Applicant's pending criminal charges;
  - b. A January 10, 2022, license denial in the State of Pennsylvania, due to Applicant's pending criminal charges;
  - c. A January 20, 2022, license denial in the State of Indiana, due to Applicant's failure to provide complete information regarding her criminal history on a license application and for having a license denial in another state;
  - d. A January 26, 2022, license denial in the State of Illinois, due to Applicant's criminal proceedings;
  - e. An April 13, 2022, license reversal of refusal, in the State of Illinois; and
  - f. A May 18, 2022, license denial in the State of South Dakota, due to Applicant's pending criminal charges.
6. Indiana Code § 27-1-15.6-12(d) provides that the Applicant may, not more than sixty-three (63) days after notice of denial of the Applicant's application is mailed, make written

demand to the Commissioner for a hearing before the Commissioner to determine the reasonableness of the Commissioner's action.

7. This is considered an administrative action by the Indiana Department of Insurance. If you choose to appeal this administrative action, please follow the aforementioned instructions. Subsequently, after the Department has received your written request for a hearing, the State of Indiana Office of Administrative Law Proceedings ("OALP") will assign an administrative law judge to preside over this matter, and you will receive more information from OALP to begin the administrative process.

**IT IS THEREFORE ORDERED** that Applicant's request for licensure is hereby **DENIED** pursuant to Indiana Codes §§ 27-1-15.6-12(b)(1) and 27-1-15.6-12(b)(9), due to Applicant's failure to disclose her multiple administrative actions, including license denials. Applicant may reapply for licensure not less than one (1) year from the date of this order.
