WHEREAS, on January 16, 2025, the Indiana Department of Insurance was notified by the Indiana Department of Child Services Child Support Bureau ("Bureau") that Respondent is responsible for child support arrearage under Indiana Child Support Case Number 7472673;

WHEREAS, the Commissioner may not reinstate any license until the Commissioner receives notice from the Bureau under Indiana Code § 31-25-4-32(m) or Indiana Code § 31-25-4-34(g) stating that Respondent has addressed the delinquency.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 3828192 is hereby placed on probationary status, effective immediately.
