**PRELIMINARY ADMINISTRATIVE ORDER**  
**AND NOTICE OF LICENSE DENIAL**

The Indiana Department of Insurance, pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.*, and Indiana Code § 27-1-15.6-12, hereby gives notice to Richard J. Long (“Applicant”) of the following Administrative Order:

1. Applicant submitted an application for resident producer licensure with the Commissioner of the Indiana Department of Insurance (“Commissioner”) on January 12, 2025.
2. Before approving an application, the Commissioner must find that the applicant has met specific requirements under Indiana Code § 27-1-15.6-6 and Indiana Code § 27-1-15.6-12.
3. Indiana Code § 27-1-15.6-12(b)(1) states, in part, the Commissioner may refuse to issue an insurance producer license for providing incorrect, misleading, incomplete, or materially untrue information in a license application.
4. Indiana Code § 27-1-15.6-12(b)(6) states, in part, the Commissioner may refuse to issue an insurance producer license for having been convicted of a felony.

5. Following a review of public records and a review of materials submitted by Applicant in support of Applicant's application, the Commissioner, being fully advised, now hereby notifies Applicant that Applicant has not fully met the requirements of licensure as stated by Indiana Code § 27-1-15.6-12(b)(1) and Indiana Code § 27-1-15.6-12(b)(6) due to Applicant's felony convictions and for failing to disclose the following criminal convictions in a license application:
- a. June 30, 2004, convictions for Resisting Law Enforcement, a Class A Misdemeanor, and Operating a Vehicle While Intoxicated, a Class D Felony, in Delaware County, Indiana under cause number 18C04-0301-FD-000047;
  - b. An October 23, 2009, conviction for OWI with Prior OWI within Five Years, a Class D Felony, in Brown County, Indiana under cause number 07C01-0706-FD-000256;
  - c. An October 23, 2009, conviction for Domestic Battery, a Class D Felony, in Brown County, Indiana under cause number 07C01-0909-FD-000329;
  - d. A March 29, 2018, conviction for Domestic Battery with Prior Conviction of Battery, a Level 6 Felony, in Hancock County, Indiana under cause number 30C01-1702-F6-000271; and
  - e. A February 5, 2024, conviction for Resisting Law Enforcement, a Class A Misdemeanor, in Morgan County, Indiana under cause number 55D01-2304-CM-000661.
7. Indiana Code § 27-1-15.6-12(d) provides that the applicant may, not more than sixty-three (63) days after notice of denial of the application is mailed, make written demand to the

Commissioner for a hearing before the Commissioner to determine the reasonableness of the Commissioner's action.

8. This is considered an agency action by the Indiana Department of Insurance. If you choose to appeal this administrative action, the State of Indiana Office of Administrative Law Proceedings ("OALP") will assign an administrative law judge to preside over this matter, and subsequently you will be contacted by the OALP with more information to begin the administrative process.

**IT IS THEREFORE ORDERED** that Applicant's request for licensure is hereby **DENIED** due to Applicant's failure to disclose Applicant's criminal history in a license application and for having been convicted of a felony.
