FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Stephanie Gabin ("Respondent") is a nonresident insurance producer holding license number 3996955 since April, 5, 2024;

WHEREAS, Respondent's nonresident producer license expires October 31, 2026;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on March 3, 2025, the Commissioner mailed Respondent certified mail article # 7099 3220 0003 6970 0159 requesting a list of appointments to Respondent's address of record;

WHEREAS, on March 6, 2025, certified mail article # 7099 3220 0003 6970 0159 was returned to the Department marked, "Return to sender";

WHEREAS, on March 20, 2025, the Commissioner emailed Respondent requesting a list of appointments to Respondent's email address of record;

WHEREAS, on March 20, 2025, the Commissioner received confirmation that delivery of Commissioner's email to Respondent was complete;

WHEREAS, on April 29, 2025, the Commissioner mailed Respondent certified mail article # 9589 0710 5270 0977 1734 69 requesting a list of appointments to an alternative address of record;

WHEREAS, on or about May 5, 2025, the signed delivery receipt for certified mail article # 9589 0710 5270 0977 1734 69 was returned to the Department marked, "Delivered, left with individual";

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
